The Board of Trustees met in Regular Session on Monday, November 3, 2025, at 6:00 p.m. at the Village Hall. The meeting was called to order by President Scott Younger. Roll call indicated the following Board Members present:

After the meeting was called to order and attendance recorded, the Pledge of Allegiance was recited.

#### Public Comments

- Brad Damery was present to ask the Board Members what the ordinance is on trailers, if there is one. There are concerns over a trailer parked on the edge of town with someone living in it. Andy believes there is a State Statute stating an individual cannot live in a camper. Scott is going to look into it and Chief Lamb is going to talk to the individual in the trailer.

**Minutes** were distributed and reviewed for the Regular Meeting held on October 13, 2025. **Rick Moma made a motion to accept the Minutes as presented. Jeff Reed Jr seconded the motion. The motion carried with all 'Aye' votes.**

**Treasurers Report** was presented by **Mackenzie Reed** indicating balances of each account, final total of bills that were paid in September 2025, and bills to be paid in October 2025. Mackenzie also informed the board of the following:

- Total cash deposits totaling \$4,086.00.
- There were 504 water bills sent out totaling \$25,958.18. At the time of the meeting, 23 shut offs were scheduled for 11/15..
- Aaron Ballion was billed \$100.00 for his trash pick-up, per **Village Ordinance 292A**.
- Mike Tarczan has submitted a TIF request. The Board Members will review it more before approving the request.
- In regards to Greg Thiele's TIF agreement, the Board Members will review terms and conditions and make a decision at the next meeting.
- Mackenzie looked into water bill software for electronic billing and auto-pay. She is going to get clarification on costs and quotes and will bring it to the December board meeting.

### **Attorney Andy Bourey**

- Andy supplied the Board Members with the Amendment to the Garbage Ordinance: **Ordinance No 292A. The Board reviewed. Rick Moma made a motion to accept the amended Ordinance as presented. Terre Moma seconded the motion. The motion carried with all 'Aye' votes.**

### **Public Works**

- Hydrant Flushing was done in October and oil was added. They plan to repaint the hydrants in the Spring. They will meet with the Blue Mound Fire Chief to discuss the results of the hydrant flushing.
- They will be rockin the (2) lots that were just purchased next to Dippin Mervs.
- Chadd mentioned looking into getting a phone directory to make it easier for customers to reach the right person. He suggested having one number and when you call there will be a list of everyone's extensions and whichever extension they choose, they then would be transferred to that person directly. Mackenzie will look into this to see if it is something that we can do.

Scott said we would need to contact her to find out and recommended starting on the Lewis Street side if we ended up taking care of it for her. The board discussed how big of a job it would be, and it would take a lot of work. It was mentioned that there are water lines down where the overgrown bushes are so whoever ends up doing the work will need to watch out for that. Chief said he will need to send Treda a letter about the property.
- RMS goes live effective 11/4/2025


